



BOATYARD REGISTRATION & AGREEMENT

(Please read the following including Terms, and Conditions overleaf)

- **NO CRADLE ARM OR PROP SHALL BE MOVED, EXCEPT BY STAFF**
- **Payment in full before launching or removal of vessels from the yard.** Bookings for launching should be made at least two days in advance.
- It is the **boat owner's responsibility** to instruct the travel lift operator as to the placement of slings prior to lifting.
- No responsibility will be accepted by boatyard for any damage to any parts of the boat, caused by the vessels approach into the well or by any actions of the lifting process. This also applies to the re-launching process.
- Boat owners must keep vessel work area clean at all times and free of oil, fuel, and paint or epoxy filler. You must not create any hazard for any other person on the hardstand.
- Welding, grinding or spray painting must be the subject of prior notification to the office together with the details of the entity which will undertake the work. Boatyard may at its discretion, forbid such work to be undertaken.
- A list of Registered Contractors permitted to work in the Port Opua Boatyard is available to all boat owners, from the Port Opua Marina Office. Registered contractors carry Indemnity Insurance to the amount of \$5,000,000.00 For the protection of all boat owners uninsured/unregistered contractors may not perform work in the Port Opua Boatyard.
- All contractors must sign in and out at the yard and marina office.
- A minimum of **third party insurance** is required whilst in the boat yard.
- All Vessel owners and contractors working on the yard must at all times ensure their activities are undertaken out in a safe manner. Specific care needs to be taken around hazardous substances which include fuel supplies and tanks, compressed air, chemicals, batteries, heating equipment and exchanges, LPG bottles, reticulation and appliances.
- Vessels using the slipway/cat trailer must provide all the necessary information for the boatyard to safely slip/haul, to avoid possible hull and appendage damage. The boat owner must check the set up of the cradle/cat trailer before slipping/hauling. The boatyard is not responsible for any damage sustained in manoeuvring of the vessel on and off the cradle/cat trailer
- The boatyard offers the service of hauling unattended vessels. Registration must be signed and a copy of insurance provided in advance. The vessel shall be berthed on the wait berth next to the travel lift and the strops positioning must be clearly marked. The Boatyard does not take any responsibility for checking the watertightness of the vessel launched from the hard and placed on wait berth without owners present.
- Ashby's Gate Access Card available from the Yard Office for a refundable deposit of \$20.00
- Only one vehicle is permitted per hardstand space. Other vehicles are allowed loading and unloading time only.
- All vehicles parking in yard do so at owners risk, the boatyard will not be held responsible for any overspray or damage.
- Vehicles illegally parked, obstructing boatyard operations may be moved or towed at owners risk and costs.
- Advertised rates are based on standard operating setup, variations will be charged in addition.
- The boat yard does not take any responsibility for waterborne antifouling collecting on your vessels decks from the water blasting process. Please check and wash your decks down as soon as placed in the yard.
